ORDERING AND OTHER INFORMATION

Same-Day Shipping on Express Orders

Placed by 1 p.m. Pacific Time
(4 p.m. Eastern Time)

(Overnight, 2-day and 3-day
express services only)

All overnight, 2-day and 3-day express orders will be shipped SAME DAY if the order is received before 1 p.m. Pacific Time, Monday through Friday. Most other orders will leave Fire Mountain Gems and Beads® the following business day by your requested ship method and will be charged at actual carrier rates.

CARRIER (Ship Code)

Low-Cost Best Way Shipping – Orders under 20 pounds will be shipped at a low cost flat rate of \$5.99 (for domestic, APO, FPO and DPO). For packages that weigh 20 pounds or more actual-cost postage as determined by our shipping carriers will be applied. Promotional items, such as a catalog or free sample in your order, are not included in the total package weight so you will not be charged shipping for these items. Please allow your carrier up to 7 business days for delivery depending on your location, the carrier and the time of year. Please visit www.firemountaingems.com/shipping for more information.

USPS (United States Postal Service)

Priority Mail – Orders should arrive 2 to 5 days after we ship. (USPS-P)

Express Mail – Orders take 1 to 3 days to arrive, depending on your location. They can arrive on Saturday, Sunday and holidays. (USPS-E)

FEDERAL EXPRESS

Overnight – Orders should arrive the next working day after we ship (usually 2 working days after we receive your order). (FX-P)

2-Day – Orders should arrive two days after we ship (usually 3 working days after we receive your order). (FX-2)

3-Day – Orders should arrive 3 days after we ship (usually 4 working days after we receive your order). (FX-3)

Ground – Orders should arrive 1 to 9 business days after we ship. (FX-G)

SHIPPING METHODS

USPS (United States Postal Service):

We now offer Priority Mail International which takes 4-8 business days to arrive at Customs after we ship.

Federal Express:

We offer two services: International Priority, which takes 2-4 business days to arrive at Customs, and International Economy, which takes 3-6 business days to arrive at Customs after we ship. Please note: we are not responsible for the time it takes Customs to clear your package.

CUSTOMS

International customers may be subject to import duties, fees and taxes, which are levied after a shipment reaches their country. **If a shipment is rejected because of customs clearance charges or refusal to accept delivery, the customer will be responsible for any costs incurred, including international shipment and handling.**

RETURNING MERCHANDISE

We happily accept returns and exchanges of regular merchandise, including precious metals, returned within 90 days of the original order date on the invoice (we do not accept returns of special order products or items containing a hazardous material). Just complete the return form on the back of your invoice, attach the mailing label from the front of the invoice, apply appropriate postage and drop the return in the mail. Please do not send C.O.D. as we cannot accept these deliveries. **All product returns must be unaltered (for example: on original strand) and accompanied by a copy of the original invoice with their original Fire Mountain Gems and Beads label and packaging.** We will process your return within five days of receipt.

Product exchanges will be priced at the same discount as the original order, and all other items will be priced as a new order, so please add \$5.99 for postage for these types of exchanges. Order overpayment and credits to institutional customers will be refunded via credit on Fire Mountain Gems and Beads accounts, which have no cash value, but are fully available to be applied to any future orders.

In the event that you return a large quantity of items for which you have received assortable or quantity discount pricing, we reserve the right to recalculate your order total based on the actual items you kept. We are unable to accept returns of books and videos that have been opened.
